Library report



Our Christmas festivities include a beautifully decorated tree and our annual bauble hunt. As a token of appreciation, each volunteer received a gift for their dedicated hard work.



Surrey Police has undergone a police efficiency, effectiveness, and legitimacy (PEEL) inspection by His Majesty's Inspectorate of Constabulary and Fire and Rescue (HMICFRS). Chief Constable Tim De Meyer welcomes the report, acknowledging areas of decline in performance since the last inspection in 2021. The report highlights both areas for improvement and positive aspects, including correct crime recording, investment in the contact centre, innovative schemes, fair use of stop and search powers, and improved community engagement. While addressing challenges, the force is committed to ongoing improvement and collaboration with partners.
