

Proposal	Change of use of land to allow for stationing of 5 additional caravans on existing caravan site; associated works comprising alteration of levels and hardstanding; soft and hard landscaping (part retrospective).
BPC Response	Bramley Parish Council objects to this application. LPP2 only allocates 15 new GTR pitches over the whole Borough up to 2032. 3 of these are at Burnt Hill, and in the location which is the subject of this application. An additional five pitches exceed the number of pitches for the area, and we therefore object on that basis. We note that the site has already been overdeveloped and therefore question the need for additional pitches. We also have concerns about the resident population of GTR numbers in the area outnumbering the settled community in the area which is in danger of happening if such development continues at the current rate.

Report from PC Greenaway

The authorities have made significant headway in the recent incidents involving the killing of 14 sheep by an alleged vehicle on a farm field. Two individuals have been arrested, and the vehicle in question has been seized. The investigation is ongoing, but the authorities are committed to ensuring justice is served. Moreover, a suspect has been apprehended concerning multiple graffiti incidents in Woking and Waverley, although their involvement in the Bramley graffiti remains unproven. Those interested can stay updated on the Waverley Beat Facebook page. The police are taking decisive action to address both matters and prevent further occurrences.

Cllr Jane Austin recently engaged in a discussion with PC Gavin Greenaway of Waverley Beat - Surrey Police, who has requested to convey the following information via the LW email: Unfortunately, four burglaries have been reported in LW and one in Wonersh Park recently, with indications of one (or possibly more) attempted burglaries. Given the timings and methods observed in these incidents, it is reasonable to suspect the involvement of the same suspect (or group). Police are actively investigating these incidents and gathering evidence.

The Surrey Police Burglary Patrol team is active in the area, conducting marked and unmarked patrols, particularly during the early evening hours. Officers in uniform and plain clothes will be present, conducting patrols on foot.

Suppose anyone observes anything suspicious or wishes to report any activity or potential evidence. In that case, the quickest method is via the Surrey Police live chat forum accessible at the [Contact Us | Surrey Police](#). Additionally, individuals can utilise the [Suspicious Activity Portal | Surrey Police](#) to upload footage or other relevant information for police review.

As a general precaution, residents are advised to review their home security measures, ensure all doors and windows are locked, and consider leaving lights or a radio on when away from home. Efforts should be made to minimise access points to the upper floors. Anyone who notices suspicious behaviour or individuals in the woods along the LW riverside is encouraged to call 999 immediately.
